# San José Women's Junior Sabre World Cup Costa Rica. September 17-18, 2016

## To all federations affiliated to FIE

We have the pleasure to invite you to the Women's Junior Sabre World Cup to be held in San José, Costa Rica from September 17th to 18th.

## Regulations

### Organizer

The San José Women's Junior Sabre World Cup will be organized by the Costarrican Fencing Federation under the auspices and authority of the Fédération Internationale d'Esgrime (FIE).

### Place and Date

The World Cup will be held in the city of San José from the 17th to the 18th of September 2016.

### Schedule

#### Saturday, Sep. 17th

8:00 A.M. - 9:30 A.M. Registration, accreditation and weapon control.

5:00 P.M. Semi finals and Final.

#### Sunday, Sep. 18th

8:00 A.M. - 9:30 A.M. Registration, accreditation and weapon control.

10:00 A.M. Draw for the position on the match sheet.

10:30 A.M. Beginning of the team competition.

5:00 P.M. Semi finals and Final.

### Equipment of Fencers

The personal equipment of the fencers must comply with the FIE rules.

## **Entries**

The World Cup is opened to all fencers with a valid FIE licence who were under 20 years old at midnight on 31st December 2015 (cf o.80). Participants will have to present their passport at the time of accreditation as proof of age.

The entry fee is €15 Euros per participant in the individual competition. It is to be paid on the day of the accreditation.

Entries should be done by the National Federations in the FIE's website.

## **Anti-doping**

Controls will be carried out in compliance with the prevailing WADA, FIE and IWAS Regulations.

## **Referees**

Participating delegations must be accompanied by the number of referees provided for by article 81 of the FIE rules:

1 to 4 fencers : No obligation

5 to 9 fencers: 1 referee

## **Local Transportation**

Transportation will be available to and from the venue at fixed schedules to participants staying at the official hotels.

### Official language

The official language is Spanish, but English is understood and spoken in most places.

### Local and foreign currency

The Costarican Colón is the official currency, but U.S. Dollars are widely accepted. (1 U.S. Dollar = ₡540).

### International credit cards and transfers

The main international credit cards (Visa, MasterCard, American Express, etc. . ) can be used to make purchases and in major hotels, restaurants, car rental agencies and travel agencies . These cards are also used to withdraw cash at ATMs.

In addition, Western Union Money Transfer and Money Gram companies have representatives in Costa Rica.

### Electricity

Voltage: 110 V

Outlets identical to those in USA .

### Telephone and Internet

The country code for Costa Rica is 506.

Wi-Fi will be available at the venue.

### Weather

In Costa Rica the average annual temperature is around 21 to 27 degrees Celsius or 70 to 81 degrees Fahrenheit and the coolest months of the year are November, December and January. The rainy season here lasts from May to November, so you should expect heavy rain during **September**.
